

TERMS OF USE

Effective on: March, 2026

By accessing or using the Easy Clean: Files & Privacy (“App” or “Service”), you are agreeing to enter into a legally binding contract with AXIONIQ LIMITED (“we”, “us”, or “our”). Please read it carefully. If you do not agree to this contract, do not access or otherwise use any of our Service. If you wish to terminate this Contract at any time, you can do so by no longer accessing or using our Services.

A. SERVICE ELIGIBILITY

The App is intended for a general audience and are not directed at children under (13) years of age.
